# What does it mean to be a Title I School?

1. Being a Title I school means receiving federal funding (Title I dollars) to supplement the school's existing programs. These dollars are used for.....
    - a. Identifying students experiencing academic difficulties and providing timely assistance to help these students meet the State's challenging content standards
    - b. Purchasing supplemental staff/programs/materials/supplies
    - c. Conducting parental involvement meetings/trainings/activities
    - d. Recruiting/Hiring/Retaining Highly Qualified Teachers
  2. Being a Title I school also means that we will continue to encourage parental involvement and parents' rights that go along with that.

## What is the building's Title I School Improvement Program?

1. The Building's Title I Plan addresses how the LEA will use Title I funds throughout the school system. Topics Include:
    - a. Student academic assessments
    - b. Additional assistance provided struggling students
    - c. Coordination and integration of federal funds and programs
    - d. Parental Involvement Strategies, including the District's Parental Involvement Plan
  2. You, as a Title I Parent, have a right to be involved in the development of the Building's Title I Plan

- Whether or not the teacher has met Kansas licensing criteria for the grade levels and subject areas being taught;
  - The baccalaureate degree and any other graduate certification or degree and the field of discipline of both;
  - If services are provided by paraprofessionals, their qualifications;
  - If the teacher is teaching under an emergency or professional waiver

## Parent Right to Know

- Parents will be contacted by the school if their child(ren) is taught for four or more continuous weeks by a teacher that does not meet the appropriate state certification standards.
  - All students/families served in schoolwide buildings and students/families served in targeted assistance programs must complete a parent school compact.
  - All parents will be informed they have the right to request their child'/children's state assessment scores and they have a right to obtain the school and school district state report cards.
